### Minutes for Batemans Bay Orchid & Foliage Soc. Monday 2<sup>nd</sup> March Club meeting 2015

Meeting opened at 7:30pm by President Robert Fish with Members & Visitors welcomed.

First item to be discussed is the Treasurers report held over from the AGM.

The President requested that the Treasurer be allowed to present the report and any questions to be left until that time.

Treasurer Margaret Turner then presented the report from the AGM in November 2014.

- Dorothy Kauffman asked questions in relation to the running of Grumpy's Shed and some of the cheque statements. Margaret was able to respond to questions in relation to the cheque statements and advised some were outside the reporting timeframe.
- Brian Perkins advised that accounts did not reflect the true nature of the expenditure and income and requested that all items (Shows, raffles, purchases etc) be itemized so that they show a true statement of the accounts it was agreed that in future accounts would reflect the income and expenditure more accurately.
- Brian Perkins also spoke on the purchase of the 2015 Calendars. As there were no further questions the Treasurer moved that the treasurer's report be accepted seconded Peter Stubbs.
- Further request that the treasurers report to include all stock as at 1<sup>st</sup> October 2014.
- The Auditor Bernie Creenane is to be retained for 2015. Moved Margaret Turner seconded Brian Coulton passed on a show of hands.

At this point we broke for supper

General Meeting then resumed at 9:20pm

Members present as per attendance book.

Apologies: Norm Kemp, Kate Willis, Bill Giust & Phil & Jill Bailey

Secretaries Report: Ron Boyd advised that the secretaries minutes as printed be accepted.

- Tony Groube advised that item 6 of the minutes was incorrect and moved a motion to ad item 6a (see amended minutes further in this newsletter) moved Tony Groube seconded by Sylvia Hawkins passed on a show of hands.
- Further to the above motion Tony Groube also moved that they be added to the next newsletter seconded by Anne-Marie Collins passed on a show of hands.
- The President also tabled an amended copy of the printed minutes as there were a number of inaccuracies in the printed minutes.
- Tony Groube moved a motion that all correspondence and reports for the newsletter be vetted by the Committee prior to publishing. seconded by Maureen Miller passed on a show of hands

#### Matter s arising from the minutes:

- Discussion re the Christmas party Dinner. As per the last newsletter a letter was to be forwarded to the club management advising of our concerns.
- The President advised that the Secretary was to write to the club and when he requested confirmation from the Secretary this letter had not been sent.
- There was then a discussion in regard to emails forwarded between both the President & Secretary.
- At this point The Secretary Ron Boyd read a prepared statement of resignation from the committee effective immediately and he left the meeting.
- Brian Perkins then thanked Ron for his contribution and hard work for the society and wished him well for the future.
- The President then advised the members present that a Secretary is required as per our constitution and if anybody wishes to put up their hand for the job.
- Matt Janjak then nominated Peter Stubbs for the position. Peter accepted the nomination as Secretary.

#### Matters arising from the minutes Cont:

• Peter Stubbs raised the annual point score allocation as published in the last Newsletter he advised that the points are only allocated if you receive a place or plant of the night. Peter's concern is that there is no incentive for members (particularly the Novice) to bench their plants. Peter moved a motion to receive 1 point (per class only) for benching seconded by Anne-Marie Collins and passed by a show of hands

The points score will now be:

- 1. Plant of the night 4 points
- 2. First place 3 points
- 3. Second place 2 points
- 4. Third place 2 points

5. Plus 1 point per class benched (irrespective of number of plants benched per class)

- 1. Brian Perkins addressed the meeting in regard to the letter that he had received. Brain was concerned as to the context of the financial reports and to the Auditors report. He indicated that the stock on hand belonging to the club was not accurately accounted for. That there is a need to show accurate accounts and that the reporting is transparent. Brian was also concerned that the letters context was not done in a respectful way.

**Item 3:** President Robert Fish moved a motion to combine the Australian Native show with the Conference on October long weekend, Seconded Peter Stubbs. After discussion it was passed on the show of hands.

There was a little confusion as to the class it was to be benched in (Vandaceous, Aust Native or Misc). Sartylis is a small group of plants of 5 registerd hybrid plants derived from crossing Sarcochilus and Rhynchostylis. As this is a hybrid between an Aust Native and an Exotic species the class for benching is Vandaceous. So if you have a Sartylis in your collection can you mark our tag for future reference.
