- Opening balance \$17061.73; income \$2370.63; expenditure \$1532.72. Unpresented cheques to the value of \$86.00. Closing balance \$17899.64.

Grumpy's shed stock value as at 31/10/17 \$3753.26.

Anne-Marie had also prepared the reconciliation of the Native show, which was presented and indicated that the show was run at a loss of \$833.37. Seconded by Una Roberts

Margaret requested payment of outstanding accounts, Seconded Brian Coulton. Carried

## 3. GENERAL BUSINESS:

- a. Next General Meeting: Christmas party: Ron explained that the committee had arranged for the Christmas function to be in the normal meeting room at the Soldiers Club. Menu was in the October newsletter – choice of 2 hot meats and vegetables and 3 salads. There would also be 2 deserts. Cost is \$25.00 per head. Members were asked to agree to a motion for BBOFS members to pay \$15 head with the Club subsiding the other \$10. Non members to pay full price. Moved Ron Boyd Seconded Min Purtell
