2. TREASURER'S REPORT:

Treasurer Anne-Marie presented the monthly report. Balance as at 1st September was \$17,715.91. Income for the month was \$2,682.70 which included \$1150.85 from the Spring Show; Bunnings BBQ on 28/9 of \$499.25 and Grumpy's shed for August of \$866.40. Expenses for the month were \$6,822.72 which included show expenses for \$1070 (judges costs, prize monies, & consumables), Garden City Plastics for Grumpys' shed \$4440.01, affliations \$149, guest speaker \$90.00 and insurance of \$160. There is one unpresented cheque for \$23.00. Bank balance at 30/9/16 is \$13,575.89. Once unpresented cheque is cleared it will be \$13,552.89. Anne-Marie asked if there were any questions relating to either the monthly statement or the Spring Show reconciliation. Rob Fish asked if the president could explain why there was about a \$1000.00 loss over the two (2) shows held so far this year. Several points were raised that helped to explain some of it. They were:- banner reprinting costs - \$250 each show; no sponsorship for show prize monies; food costs – usually members are asked to provide food items for the two days and the decrease in the cost associated with hire of tables by vendors (down by \$125.00 in Spring show).

3. GENERAL BUSINESS:

a. Next General Meeting is the AGM. There will be a short general meeting commencing at 7.30pm which will cover correspondence and financial reports. That meeting will then be suspended. The minutes from the Special meeting in February will be approved and the financial statement for the year will be presented for approval. This will be followed by the Returning Officer taking the chair. The election of office bearers and the committee will then take place. The Returning Officer will hand over to the duly elected president who will then discuss any motions that need to be completed. Once done, the AGM will be closed and the normal monthly meeting will resume with the new office bearers and committee in place. Members have been provided with information relating to the motions as well as a copy of the February meeting minutes.

- b. Spring Show Ron spoke about the Show and he felt it had been a success. It was reported that there were probably about 500 people thru' the doors over the two days. Ron thanked all concerned for benching plants as well as those who assisted over the set up and take down as well as during the two days of the Show.
- **c. Growing Experience plants** as Liz and Tony have flowered their plant, the growing experience is now completed.
- d. Plant of the night certificates Margaret getting them done and will be available at the Christmas party.
- e. Department of Fair Trading has released a updated version of the Model Constitution. There are some changes that need to be incorporated into our Constitution. If this is completed and presented to them by 1st September 2017 it can be done without charge. However for BBOFS to achieve this, we would need to call and have Special Meeting to discuss and approve changes before then. For further discussion with the new committee.
- f. Bunning BBQ next BBQ is Friday 14th October. Member assistance was

- requested and as there were only a few members present, Ron will follow up with members to gain further assistance.
- g. Native Show catering further to the discussion relating to Show expenses Ron requested members help with food (cakes, slices etc) items for the show – Thursday night after judging as well as Friday and Saturday.
- h. Banners for Show are with Ron Price having the dates changed.
- i. Historical Society Open day the committee decided to participate in this activity. It will be a display only. There will be membership forms, information about the Show and plants for display. Ron and Leanda have offered assistance and Margaret will supply the table and ensure there are membership forms and information relating to the show available.
- j. Christmas Party members present were provided with 4 options for venues for this. Members were asked to put a 1st & 2nd choice on the menus provided. The outcome was The Café at the Botanical gardens won with a clear majority. The cost of this meal is \$27.50 per head. The club will need to decide how much it will subsidize members at the November meeting. Menu will be included with the newsletter. Members who will not be present at the November meeting will need to notify either the secretary or the treasurer if they wish to attend. Final numbers will need to be with the Café at least 10 days prior to the date which is Wednesday 7th December. Members are asked to arrive between 11.30 and 12md for a brief meeting (correspondence and financial reports only) which will commence at 12md. Lunch will be available from 12.30pm.
- **k. Growing Experience** Tony showed one of the orchids that he and Liz had

grown as part of the Growing experience. The plants are placed so that they get mostly morning sun, some natural water (rain). They use 9 month slow release Osmocote and when repotting use a 50:50 mixture of blood and bone and dolomite. They also use a magna fertilizer with each watering which provides plants with a small amount of fertilizer with each watering.
